## MEMORANDUM FOR ALL USAFA PERSONNEL

SUBJECT: Consolidated USAFA Exceptions to Policy on the Use of Masks

- 1. This memorandum is issued pursuant to References (a) through (e), and an update to Reference (f). All individuals, regardless of vaccination status, must wear masks while indoors on USAFA except children ages five and under. Fully vaccinated status is defined by DoD as having completed the initial shot series, plus two weeks; a booster shot is not required for an individual to be considered "fully vaccinated."
- 2. Exceptions to this policy are as follows:
- a. Fully vaccinated personnel are not required to wear masks in Sijan Hall, Vandenberg Hall and Preparatory School dormitory rooms, squadron hallways, or common use rooms. Masks remain mandatory for all personnel in all support and facility areas outside of the squadron, group, and wing areas of responsibility (e.g. cadet store, mailroom, dorm management, cadet issue, etc.).
- b. Fully vaccinated personnel are not required to wear masks inside the Cadet Gym, Falcon Athletic Center, Clune Arena, Holaday Athletic Center and Falcon Stadium. Mask wear for all athletic competitions will adhere to the current El Paso County indoor guidelines and will adjust with any updates to the El Paso County status.
- c. Fully vaccinated personnel are not required to wear masks in academic facilities including Fairchild Hall, McDermott Library, Gregory Hall, the Aeronautics Laboratory, the Center for Unmanned Aircraft Systems Research Center, Polaris Hall, Harmon Hall, and the

**Preparatory School.** Masks remain mandatory for all events in which external guests are present.

- d. Fully vaccinated personnel are not required to wear masks in 10th ABW Facilities and Doolittle Hall. Masks remain mandatory for all customer service locations where external guests (customers) are present.
- e. Fully vaccinated personnel are not required to wear masks at **Davis Airfield**. Masks remain mandatory when external guests are present.
- 3. Existing policy for mask wear remains in effect for the following: Mitchell Hall, Community Center, AAFES Facilities, Commissary and in Medical Treatment Facility (MTF) areas, to include Cadet Medicine, Community Center Pharmacy, and Mental Health.
- 4. Academy School District 20 facilities will adhere to Academy School District 20 guidelines.
- 5. Specific areas within the cadet area and Preparatory School may continue to require masking at the discretion of the Mission Element or Department lead and will be posted as such.
- 6. The senior ranking person in any group may still require masking for any gathering or event. Additionally, any permanent party or cadet may ask the senior ranking person to require masks, and the request must be honored.
- 7. Masks must still be carried and available at all times. When engaging with an individual wearing a mask inside any of the exempted areas, the non-masked person must immediately don a mask upon reaching six feet from the masked individual.
- 8. Exceptions to policy will be assessed weekly and may be modified.
