Lloyd J. Austin III Secretary of Defense



Lloyd James Austin III was sworn in as the 28th Secretary of Defense on January 22, 2021. Mr. Austin is the principal assistant to the President in all matters relating to the Department of Defense and serves on the National Security Council.

Mr. Austin was born in Mobile, Alabama, and raised in Thomasville, Georgia. He graduated from the United States Military Academy with a Bachelor of Science degree and a commission in the Infantry. He holds a Master of Arts degree in counselor education from Auburn University, and a Master of Business Management from Webster University. He is a graduate of the Infantry Of cer Basic and Advanced courses, the Army Command and General Staff College, and the Army War College.

His 41-year career in the Army included command at the corps, division, battalion, and brigade levels. Mr. Austin was awarded the Silver Star for his leadership of the Army's 3rd Infantry Division during the invasion of Iraq in 2003. Seven years later, he would assume the duties of Commanding General of United States Forces – Iraq, overseeing all combat operations in the country.

After a tour as the Army's Vice Chief of Staff, Mr. Austin concluded his uniformed service as the Commander of U.S. Central Command, responsible for all military operations in the Middle East and Afghanistan. In this assignment, he led U.S. and coalition efforts to battle ISIS in Iraq and Syria. He retired from the Army in April, 2016.

Since his retirement from military service, Mr. Austin served on the Boards of Directors for Raytheon Technologies, Nucor, and Tenet Healthcare.

SECRETARY OF THE AIR FORCE FRANK KENDALL

Frank Kendall is the 26th Secretary of the Air Force responsible for organizing, training, and equipping the U.S. Air and Space Forces. In this capacity, he directs the Department of the Air Force's annual budget exceeding \$173 billion, provides Air and Space forces to combatant commanders for global military operations, and is accountable for the welfare of nearly 700,000 active duty, Guard, Reserve, and civilian Airmen and Guardians and their families.

Mr. Kendall has more than 50 years of experience in engineering, management, defense acquisition, and national security affairs across private industry, government, and the military. He was a consultant to defense industry firms, non-profit research organizations, and the Department of Defense in the areas of strategic planning, engineering management, and technology assessment. Additionally, he is an attorney and was active in the field of human rights, working primarily on a pro bono basis.



Earlier in his career, Mr. Kendall was Vice President of Engineering for Raytheon
Company, providing management and direction to the engineering functions
throughout the company and for internal research and development. He also served as a Managing Partner at Renaissance
Strategic Advisors, a Virginia-based aerospace and defense sector consulting firm.

Within government, Mr. Kendall held numerous posts including Under Secretary of Defense for Acquisition, Technology and Logistics as well as Deputy Director of Defense Research and Engineering for Tactical Warfare Programs in the Office of the Secretary of Defense. He is a former member of the Army Science Board and the Defense Intelligence Agency Science and Technology Advisory Board, and was a consultant to the Defense Science Board.

Mr. Kendall is a graduate of the U.S. Military Academy at West Point. He served 11 years as an active duty Army officer, including assignments in Germany, teaching Engineering at West Point, and in research and development positions.

Lt. Gen. Richard M. Clark is the Superintendent, U.S. Air Force Academy, Colorado Springs, Colorado. He directs a four-year regimen of military training, academics, athletic and character development programs leading to a Bachelor of Science degree and a commission as a second lieutenant in the United States Air Force or United States Space Force.

Lt. Gen. Clark graduated from the U.S. Air Force Academy in 1986. BRIGADIER GENERAL PAUL D. MOGA

Brig. Gen. Paul D. Moga is the Commandant of Cadets, U.S. Air Force Academy, Colorado Springs, Colorado. He commands the 4,300-member Cadet Wing and more than 200 Air Force and civilian personnel. He guides military, leadership, character development, Basic Cadet Training and Expeditionary Skills Training for the Air Force Cadet Wing in addition to providing facilities and logistical support.

Brig. Gen. Moga is a 1995 graduate from the U.S. Air Force Academy. He earned his pilot wings at Laughlin Air Force Base, Texas, and went on to fly the F-15C Eagle as an operational and formal training unit Instructor Pilot. His assignments include F-22 Raptor FTU Initial Instructor Pilot Cadre, first F-22 Demonstration Team Commander, Chief of Air Combat Command's Senior Leader Management Division, the NATO Defense College, and Deputy Division Chief in the U.S. European Command. He has commanded at the squadron, vice wing and wing level.

Prior to this assignment, Brig. Gen. Moga was the Deputy Director of Operations for Headquarters United States Northern Command, Peterson Air Force Base, Colorado. In this capacity, he was the principal advisor to the Commander, U.S. Northern Command for all operational matters, providing strategic guidance to plan and execute missions within the area of responsibility; land, maritime, Homeland Defense air operations, Defense Support to Civil Authorities and Theater Security Cooperation, to include the Arctic.

He is a command pilot with more than 2,600 flying hours in the F-15C, F-22 and F-35A Lightning II, including more than 250 combat hours in support of operations Southern Watch and Allied Force.

BRIGADIER GENERAL LINELL A. LETENDRE

Brig. Gen. Linell A. Letendre is Dean of the Faculty, U.S. Air Force Academy, Colorado. She commands the 750-member Dean of Faculty mission element and oversees the annual design and instruction of more than 500 undergraduate courses for 4,000 cadets across 32 academic disciplines. She also directs the operation of five support staff agencies and faculty resources involving more than \$350 million.

The general graduated from the Air Force Academy in 1996 as a distinguished graduate with a Bachelor of Science degree in Astronautical Engineering. After serving as an Acquisition Officer, Brig. Gen. Letendre became a Judge Advocate through the Funded Legal Education Program. She graduated from the University of Washington law school with high honors and was named to the Order of the Coif and the Order of the Barristers. She is barred at the U.S. Supreme Court, the Supreme Court of Washington, the U.S. Court of Appeals for the Armed Forces and the Air Force Court of Criminal Appeals. Prior to this assignment, she served as the Permanent Professor and Head of the Air Force Academy's Department of Law.



Brig. Gen. Letendre previously served as a Staff Judge Advocate at Scott Air Force Base, Illinois, and also represented the Air Force in appellate review of all courts-martial as the Deputy Chief Trial and Appellate Counsel. Additionally, she previously served as the Legal Advisor for the DoD Comprehensive Review Working Group, where she advised on legal and policy issues surrounding repeal of "don't ask, don't tell." She also defended the Air Force in a range of federal civil litigation involving military personnel, served as Chief of Strategic Communication for the Judge Advocate General and defended Airmen as an area defense counsel.

Academy cadets awarded international graduate scholarships

U.S. AIR FORCE ACADEMY, Colo. – Three cadets from the Class of 2022 were awarded scholarships for advanced degrees in the United Kingdom. Cadets First Class Samuel Brody and Allyson Burba were named to receive the Marshall Scholarship and C1C Adrienne Eckstein is named to receive the Holaday Scholarship.

The Marshall scholarship is funded by the U.K. Government and awarded annually to qualifying Americans to pursue a graduate degree in any field of study at a U.K. academic institution. Up to 50 scholars are selected each year.

The Holaday scholarship funds graduate work at the University of Oxford. Bart Holaday, a 1965 Academy graduate, and his wife, Lynn, established the scholarship to honor Holaday's mother.

"Both scholarships are highly competitive programs which aim to sharpen recipients' intellectual abilities and strengthen the enduring relationships between the British and American people," said Dr. Helen Meisenhelder, director of the Academy's graduate studies program. "These programs increase a cadet's ability to think critically about problems of national and global concern. Ultimately, the programs will give them insight on the issues they will face as leaders in the Air Force."

Brody, a Fort Lauderdale, Florida native, is an aeronautical engineering and mathematics double major who hopes to attend the U.K.'s University of Bristol and pursue a degree in engineering science.

"The opportunity to pursue this education through research, alongside the incredible resources of courses in the engineering sciences, provides the perfect opportunity for pursuing novel design features for future aircraft," said Brody. "Cultural education within the U.K. would equip me with the tools to be an Air Force officer at the forefront of innovation with an ability to balance more than the ever-important equilibrium between hard and soft power in the international context."

Burba, an Okemos, Michigan native, is an electrical and computer engineering major who wants to attend the London School of Economics and Political Science to pursue a degree in gender, peace and security.

"I aspire to lead and serve in the United States Air Force, changing the reality I face for those who follow," said Burba. "To keep pace with our adversaries, we must take full advantage of our available resources, harnessing the diversity of thought available in our nation to solve the complex problems presented by the defense of the U.S. and our allies"

Eckstein, a Vicksburg, Mississippi native, is a civil engineering major and intends to pursue a degree in Environmental change and management at the U.K.'s University of Oxford.

"I'm incredibly humbled and excited to be selected as a representative of the Air Force for this opportunity in the UK," said Eckstein. "The education gained at Oxford will allow me to be more informed about climate change and will shape my decisions throughout my career in the Air Force."
